Consequently, seventeen (17) committees have been established by this Assembly.

Pursuant to Section 8 of the County Governments Act, 2012 and in compliance with Section 46 (d) of the County Assembly Service Act, 2017 respectively, you were able to vet and approve eight (8) County Executive Committee Members. In addition, the Committee on Appointments was able to vet and approve the appointment of two members to the Assembly Service Board.

Honorable Members,

It is impressive to note that the just concluded recess was in the real sense a working recess. Members took some time out of their busy schedules within their wards in order to do the following:-

- (i) Hold a consultative meeting with Her Excellency the Governor at Mombasa as from 15th to 19th December, 2017.
- (ii) Attend an induction workshop for the Assembly leadership at Mombasa as from 16th to 21st January, 2018.
- (iii) Prepare committee annual work plans as from 8th to 13th January, 2018 at Machakos.
- (iv) Conduct oversight and/or benchmarking activities on;
 - a) Sand Conservation and Utilization by the Committee on Environment, Energy and Mineral Investment Development as from 16th to 20th January, 2018.

- d) County Tourism, Sports and Culture development projects by the Committee on Tourism, Sports and Culture for the financial years 2015/2016 and 2016/2017 as from 1st to 3rd February, 2018.
- e) County Agriculture, Water and Irrigation projects for the financial year 2016/2017 by the Committee on Agriculture, Water and Irrigation from 5th to 10th February, 2018.

As the House now resumes, the Committee on Liaison shall soon come up with the final work plans containing the approved budget allocations for the committees' operations running from January to December, 2018. It is therefore expected that the committees shall continue with their oversight role which includes continuous inspection of the county executive programs when need arises, regular benchmarking trips and committee trainings.
