KITUI COUNTY VILLAGES BILL, 2014 (C/A BILL NO. 15, 2014)

Notice is hereby given that the Chairperson, Committee on Administration and Coordination of County Affairs intends to move the following amendments to the Kitui County Villages Bill, 2014 (C/A Bill No. 15, 2014) as proposed in His Excellency the Governors Memorandum dated 5th December, 2014 at the Whole County Assembly Committee stage.

CLAUSE 4

THAT, amend clause 4 by deleting the words "two hundred and forty seven (read 247)" between the words **County** and **Villages** and replace thereof with **two hundred (read 200)**

CLAUSE 9

THAT, amend clause 9 by deleting all the words in the clause and replace thereof with the provisions of Section 52(3) of the County Government Act as follows;

A village administrator shall coordinate, manage and supervise the general administrative functions in the village including—

(a) Pursuant to paragraph 14 of Part II of the Fourth Schedule to the Constitution—

(i) Ensuring and coordinating the participation of the village unit in governance; and

(ii) Assisting the village unit to develop the administrative capacity for the effective exercise of the functions and powers and participation in governance at the local level; and

(b) The exercise of any functions and powers delegated by the County Public Service Board under section 86.

(4) In carrying out the functions and obligations in subsection (3), a village administrator shall be responsible to the relevant Ward administrator.

CLAUSE 10

THAT, amend clause 10 by deleting the words "five (5) other members with the village administrator as the secretary" immediately after the words **administrator and** in the fourth line of the clause and replace thereof with

"Not less than three and not more than five village elders with the Village Administrator as the Chairperson".
