Education, Training and Skills Development, Human resource office, Ministry of Environment and Natural resources, among other offices are hosted.

REGREATABLY NOTING THAT, the office damage caused by the inferno was far reaching with no attempt by the County Government responsible officers to respond notwithstanding the proximity to the holding ground for the Fire Fighting Engines which is the LIUD headquarters.

The Assembly hereby resolves that:

The Speaker do form an ad-hoc Committee undertake the following;

- i. To investigate whether the County has active disaster management unit;
- ii. To investigate why the County Fire Fighting Unit did not respond to the incidence promptly;
- iii. The Committee to investigate the cause of fire and action taken by the County Government in safeguarding information vital for the necessary investigation;
- iv. The Committee to investigate whether the building is insured, damage caused to the building, office records and equipment destroyed.

That the Committee formed to give a Comprehensive report on the aforementioned issues within fourteen (14) days on approval of this motion.
