**THE KITUI COUNTY BUSINESS LICENSING BILL, 2014 (C/A BILL NO. 6, 2014)**

Notice is hereby given that the Chairperson, Committee on Trade, Industry, ICT and Cooperatives, intends to move the following amendments to the Kitui County Business Licensing Bill, 2014 (C/A Bill No. 6, 2014) as recommended by the Kenya Law Reform Commission in an advisory letter dated 25<sup>th</sup> November 2014, at the whole County Assembly Committee.

**CLAUSE 17**

**THAT**, amend Clause 17 by deleting all the words in Sub clause 17(3) (a) **“three members of the committee responsible for trade commerce and industry in the County Assembly of Kitui”** and replace thereof with –  
17(3)(a) – three members of the Kitui County Budget and Economic Forum being;

- i) The County Executive Committee Member for Finance and Economic planning
- ii) The County Executive Committee Member for Trade, Industry, ICT and Cooperatives
- iii) One person appointed by the Governor under Section 137(2)(c) of the Public Finance Management Act no. 17 of 2012.
