CLAUSES WITH AMENDMENTS

Clause 5

Section 5 Sub section 1 of the Kitui County Health Facilities Management Committees Act, in this Act referred to as “the Principal Act” is amended by deleting the provision that reads “provided the area members of the County Assembly in the Sub -County where the hospital is situated shall be at liberty to attend any meetings of the Committee in furtherance of their oversight role”

Clause 8

Section 8 of the Principal Act be amended under subsection 1 by deleting paragraph b in its entirety and substituting therefor with–

“(b) The County Executive Committee member for Culture, Youth, Sports and Social Services”

Clause 22

Section 22 of the Principal Act be amended under Sub - Section 1 by deleting paragraph b by in its entirety substituting therefor with –

“(b) Any person appointed from the County Ministry of Culture, Youth, Sports and Social Services”

THE KITUI COUNTY BUSINESS LICENSING (AMENDMENT) BILL, 2016, (C/ASSEMBLY BILL NO. 5 OF 2016)

Notice is given that the Chairperson of the Trade, Industry ICT and Cooperatives Committee intends to move for approval by the House the following Clauses to the Kitui County Business Licensing (Amendment) Bill, 2016, (C/Assembly Bill No. 5 of 2016) at the Committee of the Whole House.

CLAUSES WITH AMENDMENTS

Clause 2

Section 2 of the Kitui County Business Licensing Act 2014, in this Act referred to as the Principal Act, is amended by introducing a new definition to follow in the alphabetical order –

“county budget and economic forum” means the County Budget and Economic Forum established pursuant to section 137 of the Public Finance Management Act 2012.

Clause 3

Section 17 of the Principal Act is amended in subsection 3(a) by deleting the said subsection in its entirety and substitution therefor with the following –

“Three members of the County Budget and Economic Forum, that is

- (i) the County Executive Committee Member for Finance and Economic Planning;
- (ii) the County Executive Committee Member for Trade, Industry, ICT and Co-operatives
- (iii) one person appointed by the Governor under Section 137 (2)(C) of the Public Finance Management Act of 2012”.
