**4. NOTICE OF MOTION ON APPROVAL OF ADDITIONAL SECURITY TO MEMBERS CAR LOAN – (Deputy Leader of Minority Party)**

**AWARE**, under the Kitui County Assembly Car Loan (Members) Scheme Fund Regulation, 2014, the Members of the Assembly benefited from a credit facility (car loan) for purposes of purchasing cars for either personal or official use,

**FURTHER**, aware that these loans were required to be fully secured as provided under regulation 9 of these Regulations.

**REGRETTING**, that despite the express provision that these loans be secured before being disbursed, some members benefited from the advancements without offering adequate security.

**5. NOTICE OF MOTION ON PROVISION OF FREE AMBULANCE SERVICES (M.C.A – Mumoni Ward)**

**AWARE THAT**, Health is one of the devolved functions as contained in the fourth schedule of the Constitution of Kenya

**FURTHER AWARE THAT**, the County Ministry of Health and Sanitation provides ambulance services and charges the patients certain fees in order to allow use of the same;

**CONCERNED THAT**, majority of the Kitui County Population have no formal income and live below poverty line;

**FURTHER AWARE THAT**, every Kenyan has a right to affordable health care and that it is the responsibility of the County Government of Kitui to facilitate affordable health care to the people;

**COGNISANT** of the fact that ambulance services are sought at the very critical and desperate time when a patient or caretakers of such a patient may not be able to afford the requisite fees and that there are patients who have not been able to afford the services;

**THIS HOUSE RESOLVES THAT:**

1. The County Government of Kitui through the Ministry of Health and Sanitation shall provide ambulance services to the people of Kitui free of charge effective from 1<sup>st</sup> July 2016
