Following the withdrawal of the Governor's Reservations on Clause 5(1) of the Emergency Fund Bill No. 2 of 2018 vide her letter Ref no. CG/KTI/CORR/GV/234 dated 7th August, 2018, the Committee on Budget and Appropriations maintains its recommendations to retain Clause 5 (1) as contained in the approved report by the Assembly on 16th May, 2018 in the morning session. The Clause 5 (1) states that "*The County Executive Committee Member for Finance shall administer the County Government Emergency Fund for the County Government in accordance with a framework and Criteria approved by the County Assembly*".

The said Governor's letter under reference is hereby attached as annex 1 to this statement.
