The Assembly was able to pass and forward to the Governor for assent the following Bills three (3) during this period;

1. The Kitui County Emergency Fund Bill, 2018
2. The Kitui County Supplementary Appropriations Bill (No.3), 2018
3. The Kitui County Appropriations Bill (No.4), 2018

We also passed the following Regulations during this period;

1. The Kitui County Health Insurance Cover Fund Regulations, 2018
2. The Kitui County Climate Change Fund Regulations, 2018

Honourable Members,

We still have some pending work that was not completely dispensed off previously which includes some reports, motions, petitions and statements. This work needs to be dealt with expeditiously moving forward.

Honourable Members,

You are aware that very soon, we are expected to consider and pass the Kitui County Finance Bill, 2018 that will allow for the mobilization of revenue to finance projects for the County Government. Dispensing of this should be done within ninety (90) days of the passage of the Appropriations Bill. Also, in line with the Budget Cycle, the Annual Development Plan, 2019/2020 is expected to be

laid on the floor of the House together with the County Budget Review Outlook Paper for our consideration.
