THIS HOUSE HEREBY RESOLVES THAT the Committee on Implementation should:

1. Scrutinize and examine:
 - a) the implementation status of House resolutions passed during the Second County Assembly;
 - b) whether legislation passed by both the First Assembly and Second Assembly has been operationalized and the degree of operationalization;
with a view of reporting and updating the County Assembly on the implementation status of the said resolutions and legislation;
2. Table its report on the implementation status of County Assembly resolutions and legislation within 90 days of adoption of this Motion;
3. Be Reporting to the House on implementation status of County Assembly resolutions on a quarterly basis.
