CLAUSES WITH AMENDMENTS

CLAUSE 6

THAT, amend clause 6 as follows:-

- i. By deleting the word "designation" under sub clause 1 and substituting thereof with the word "**designated**".
- ii. By inserting the word "executive" between the words "county" and "committee" to read "**county executive committee.**"

CLAUSE 13

THAT, amend clause 13 by renumbering it to **clause 11**

CLAUSE 14

THAT, amend clause 14 by renumbering it to **clause 12**

THAT, amend Clause 15 as follows: –

- i. By renumbering clause 15 to **clause 13 (1)**.

SECOND SCHEDULE

PART 1

COUNTY FLAG

THAT, the Second Schedule be amended in Part I by replacing the coat of arms on the left side of the flag with the coat of arms recommended in Part II.

PART 11

ARMORIAL ENSIGNS

THAT, the Second Schedule be amended as follows –

- i. By deleting the words "tractor, goat, kitchen garden, agricultural produce, a dam, elephant, solar and electricity" and be replaced thereof with the word "**natural vegetation**".
- ii. By deleting the county motto "Kaunti Yĩitu", "Rasilimali Siitu" and "Maisha Maseo" and replace thereof with the words "**Rasilimali zetu, maisha bora.**"
- iii. By -
 - 1) Deleting the word "four" in between "into" and "asymmetrical" and replacing it thereof with the word "**three**"
 - 2) deleting the words "cow, hen and eggs" and replacing them with the word "**a cow**"
 - 3) Deleting the words "and onsite industry at the background" entirely.
 - 4) Deleting the words "holding a key" and replacing it thereof with the words "**wearing a graduation cap**".

THAT, the Second Schedule be amended in Part 111 by deleting the words "holding a key" and replacing thereof with the words "**wearing a graduation cap**" and further amend by inserting the words "**a banner on top with two stars on both ends**" in between the words "supporters" and "encircled".

THAT amend the Bill by interchanging the above corrected Part 1 of this Second Schedule with Part 2 to correspond with the provisions of the First Schedule.
