9.*. MOTION ON ROOF WATER HARVESTING (*Hon. Titus Kasinga-Member Mumoni Ward*)

Aware that most parts of Kitui County are water insecure,

Further aware that the County receives a considerable fair amount of rainfall during her two seasons of rain,

Concerned that much of the rain water goes to waste and if harvested would go a long way in boosting water sufficiency,

Further concerned that many buildings whether public or private lack gutters and water tanks for rain roof harvesting and storage facilities respectively,

This Assembly resolves that:-

1. All buildings funded by the County Government of Kitui shall be fitted with all round gutters and provided with at least two water tanks of at least 10,000 litres each,
2. All Bill of Quantities (BQs) such as for but not limited to classes and health facilities shall hence forth and with immediate effect contain the above two components of gutters and at least two water tanks as it may be appropriate.
3. The County Government of Kitui where necessary makes it mandatory hence forth and with immediate effect for developers of Community properties (both office , business and residential) to fit all round gutters in their buildings and provide adequate and sufficient water storage facilities for their occupants. And further, that no building plan shall be approved without the provision of the above two components.
4. That this House tasks the Department of Lands, Infrastructure and Urban Development (LIUD) with the implementation of the resolutions passed herein in this Motion.
