2. ***Sine die adjournment***

It is suggested that the House adjourn *sine die* on or around June 15, 2017, which is about **53 days** to the General Elections.

Should the House be required to consider any particular business, the Hon. Speaker can be requested to recall the House on any sitting day between June 16 and August 7, 2017 for Special Sittings. For instance, the Kitui County Finance Bill which is required to be passed 90 days from the passage of the appropriation Law and other County statutory document.

3. **Reasons for *sine die* adjournment:**

- a) Previous National Parliaments from which we are bench marking from adjourned two months before the General Elections;
- b) Members can conduct campaigns more freely;
