Honorable Senator of Kitui County, David Musila E.G.H., Hon. Members of Parliament, Hon. Members of the County Assembly; Distinguished Guests, Ladies and Gentlemen; Good Afternoon.

Before I invite you to talk to us, allow me to make some brief remarks. Honorable Members, there is no doubt that Kenya is at the dawn of a new dispensation – indeed a new chapter. Kitui County Assembly like other assemblies across the republic is however not devoid of its own daunting challenges. When we started in March 2013, we were all beginners in the role we were expected to play in the county. Lack of proper facilities and structures, shortage of staff, inadequate office space for committees and employees, congested chambers, unfamiliarity with parliamentary procedures, inadequate funds and unnecessary interference by constitutional institutions such as the Commission on Revenue Allocation, Transitional Authority and Controller of Budget, were some of the challenges we faced as a new entity in devolution.

Today I am proud to say that members of this county assembly showed resilience and accepted the challenges, listening, learning and adopting necessary measures to overcome these hurdles. Since the inception of the County Assembly Service Board, we have employed qualified personnel and organized relevant trainings, workshops and seminars consistently for both members of the Assembly and employees. We have interacted with various people who have helped us to learn and understand our mandate and how to go about our work. I am also

pleased to inform you that necessary plans are underway to construct a modern chamber.

### **Honorable Senator**

A quick glance at the membership of the First Kitui County Assembly gives me pleasure to inform you that there are a number of professionals from varying backgrounds who voluntarily abandoned their careers to join this House. In addition, women, youth and persons with disabilities are ably represented herein.

### **Honorable Senator**

As the legislative arm of the Kitui County Government, the task ahead of us is enormous, the expectations are high and the challenges intimidating. However, I want to assure you that the most encouraging thing is that the people of Kitui County are fully behind us in our efforts to change the county for the better. We shall continue to endeavor to enhance good working relations with our counterpart, the County Executive, in steering our county towards development and realization of vision 2030.

### **Honorable Senator**

Indeed we have made several notable accomplishments in the two sessions since the birth of this Assembly. I wish to reiterate here that the Assembly will not tire in ensuring the success of the County and the delivery of services to our people. The Kitui County Assembly has passed thirteen (13) Bills and forwarded them to the Governor for assent. The Assembly has likewise witnessed the adoption of various motions. Numerous statement requests have also been made. Honorable Members are becoming more proactive in initiating legislation touching on issues affecting the electorate. Moving forward, we therefore expect to handle more Bills, Petitions and Motions.
