ARMORIAL ENSIGNS

**THAT**, amend armorial ensigns as follows –

- i. By deleting the words in bottom crescent "tractor, goat, kitchen garden, agricultural produce, a dam, elephant, solar and electricity" and replacing thereof with the word "**natural vegetation**".
- ii. By deleting the words in the County motto "Kaunti Yiitu", "Rasilimali Siitu" and "Maisha Maseo" and replacing thereof with the words "**Rasilimali zetu, maisha bora.**"
- iii. Description by:-
  - Deleting the word "four" in between "into" and "asymmetrical" in the fifth line of the paragraph and replacing it thereof with the word "**three**"

**THAT**, amend in the description of the public seal by deleting the words "holding a key" between the words "man and" and "at the" in the first and the second line and replacing thereof with the words "**wearing a graduation cap**" and further amend by inserting the words "**a banner on top with two stars on both ends**" in between the words "supporters" and "encircled".

**THAT** amend the Bill by interchanging the above corrected Part 1 of this Second Schedule with Part 2 to correspond with the provisions of the First Schedule.
