(s) grading of roads by hiring a grader for a maximum of 170 hours per Ward.

By amending Clause 17 by deleting in line one the words "one million" and inserting in place thereof with the following words: - two millions...

(a) deleting the words "seventy percent (70%)" in clause 22(a) and replacing thereof with the following words: - eighty percent (80%)...
