I am in receipt of the Constitutive Agreement for the establishment of the South Eastern Kenya Economic Block (SEKEB) as signed by the Governors for Kitui, Machakos and Makueni Counties. The Agreement was submitted to my office by the Governor, H.E. Charity Ngilu on 13<sup>th</sup> November, 2019. The document is a broad policy statement based on relevant provisions of the

Constitution, the Public Finance Management Act, 2012, the County Governments Act, 2012 and the Intergovernmental Relations Act, 2012.
